

The grief felt by the loss of an Airman ripples throughout the Air Force. As painful as a loss is to our community, it pales by comparison to the grief surviving loved ones experience. The information presented in this pamphlet provides an overview of entitlements for surviving family members of fallen active duty (and their dependents), retiree, and veterans of the Armed Forces. Specifics regarding Mortuary Affairs program eligibility and entitlements are detailed in Air Force Instruction 34-242.

The Installation Mortuary Affairs Officer is the only person authorized to provide the entitlements briefing to surviving next of kin. However, it is necessary for all to have an understanding of Mortuary and Honor Guard entitlements. Thus, the installation commander appoints a military volunteer, the Family Liaison Officer (FLO), as the official link between the family and the Air Force.

Personal care of and attention to the surviving family is a proud military tradition taken seriously by those in command. Thus, the FLO interfaces with the family until an accident investigation board is complete or the family no longer wants unsolicited contact. The FLO provides any and all assistance required by the surviving family members, including working with support agencies that administer benefits following the death of a DoD member.

## MORTUARY AFFAIRS ELIGIBILITY

### ACTIVE DUTY MEMBERS AS PER AFI: 34-242

- Active duty members of the regular Air Force.
- Air Force Reserve & Air National Guard who die while on active duty or during inactive training, while en route to or from active duty or training, or while hospitalized or undergoing treatment for a medical condition aggravated by or incurred while on active duty or inactive training.
- Cadets of the Air Force Academy or members and applicants accepted into the Air Force ROTC who die while attending training camp, while hospitalized for a medical condition aggravated by or incurred during training, or while en route to or from training.
- Accepted applicants for enlistment and are under the jurisdiction of the United States Air Force.
- Any person discharged (not retired) from active duty while a patient in a U.S. government hospital and who remained a patient in the hospital at date of death.
