FOOD SERVED

Nutritious meals and snacks are served daily. The SAC is a participant in the USDA Food program. Due to USDA regulations, outside food may not be brought into the facility. We specially prepare food for children with dietary restrictions.

STAFF TO CHILD RATIO

To ensure safety and manage ability of all children, the staff to child ratio will not exceed 2:24 throughout the building. For activities requiring higher supervision (swimming, wood-working & cooking) we adhere to a 1:8 ratio. Field trips are supervised at a 1:12 ratio per group.

SPECIAL NEEDS CHILDREN

An Child and Youth Inclusion Action Team comprised of a multidisciplinary group of professionals meet to assess reasonable accommodations for children/youth will identified developmental and/or medical requirements.

ENROLLMENT POLICIES & COST

ELIGIBILITY

The following categories of personnel may utilize the Hurlburt School Age Care (SAC); Active duty military personnel assigned to or supporting Hurlburt Field, active duty military personnel and their dependents who are not assigned to or supporting Hurlburt Field, DoD NAF civilian employees and contractors assigned to Hurlburt Field. Eligibility is verified with proper identification.

Priorities for enrollment (AFI-34-144)

1st Priority: Wounded Warriors, single or dual active duty Military Service members, Single or married DoD civilian employees with a working spouse.

2nd Priority: DoD civilian employees, surviving spouses of military members who died from a combat related incident and DOD Civilian employee with a same-sex domestic partner or a student.

3rd Priority: Surviving spouses of military members and those acting in loco parentis on behalf of the aforementioned or in the case of a DoD civilian employee with a same-sex domestic partner or student.

4th Priority: Federal employees from non-DOD agencies and military retirees on space availability.

The hourly rate of care is \$5. There is a weekly transportation fee of \$12.50 for Before or After school and \$25 for both. Fees based on DoD guidelines according to the Military Child Care Act of 1996. These fees are updated annually.

Contracts are payable weekly, biweekly, or monthly. Payments are due by the close of the 2nd business day that your child attends the program. A late fee of \$10 will be included with payments made after this time.

There is a 10% discount for multiple children enrolled. Early Release days are open for all schools except private schools unless they coincide with the normal Okaloosa County School System.
